As per the responsibility entrusted by the Govt. of Odisha, the society shall function as the nodal society for conversion of procured Eri Cocoons (Dry Eri shells) of different Sericulture zones of Odisha to spun silk yarn vide HT&H Dept. Govt. of Odisha Letter No. 505 dated 20.01.2023.

2. The Agency must meet the following standard specification parameters i.e.2/210 Nm & 0-60 Nm.
3. Total quantity of Eri Shells to be converted to spun silk yarn- 1200 Kg
4. The Eri shells will be delivered to the selected Agency/ Spinning mill from Champeswar Eri Rearers Cooperative Society Ltd., camp at Bhubaneswar.


