5. The rate quoted should be inclusive of all taxes (ref. to GST) & transportation cost (rate up to door delivery).
6. The supplier/ authorized agent of the supplier may be present with materials submitted in the tender for display at the time of opening tender.
7. The Authority reserves the right to accept any or rejects all tender without assigning any reason thereof.
8. Performance Security :-
The supplier/ manufacturer shall submit an EMD of 10,000/- (Rupees Ten Thousand) only in the form of Bankers Cheque/ Demand Draft in favour of Assistant Director of Sericulture, Bhubaneswar. The EMD does not carry any interest. Quotation submitted without EMD shall be summarily rejected.
9. No advance will be paid. However payment will be released within 15 days after receipt of the items in good condition & confirm of specifications.
10. GST Certificate/ PAN/ TIN number issued by the concerned Department should be indicated.
11. Liquidated damages for delay & non supply @5% will be deducted from the bill per week for not supplying the items within the stipulated time subject to maximum of 10% of the total cost of the article.
